

# Pebeo Products

Consumer Product Safety Improvement Act (CPSIA).

We do business with the highest integrity and did not wait for the enforcement of the Consumer Product Safety Improvement Act -CPSIA or Consumer Product Safety Improvement Act of 2008 to make sure we provide only the safest and best quality products to every one of our customers.

The 'certificate requirement' is mandatory in our case for products manufactured after November 12th 2008 because our products are subject to the ASTM D 4236 ruling.

All the products Pebeo sells comply with the ATSM D 4236 standards, and are labeled in accordance with their specific classification. The Pebeo brands Setacolor Transparent, Opaque, Soleil, Setasilk and the Water Based Guttas in tubes and Setaskrib Markers are bearing the ACMI AP seal label, for no health labeling required. This means that they are non-toxic in any ways for adults or children ( and without lead or phthalate). Pebeo Soie has ACMI classification ASTM D 4236 of HEALTH.

ACMI ( Art and Creative Material Institute) is THE American program of certification and classification for art and crafts material in collaboration with the CPSIA rulings for arts and crafts industry material.

All the goods Pebeo sell to Dharma Trading are tested, classified and certified not only by our own laboratories in France/and or/China , but also by an independent American Laboratory: The Duke Occupational and Environmental Medicine / Duke OEM Toxicology Duke Occupational Health Service, in Durham NC 27705 , which is working in accordance with the Consumer Product Safety Improvement Act (CPSIA) and with all the USA health requirements and certifications.

The Certificate of Compliance is requested by the USA customs from the Importer of record, which is now Pebeo Inc., and the certificates will be available also to our distributors and retailers, in the coming months. We are already working on a certificate data base that will be added as a link on our website in order to be in conformity when we will import into the USA some products manufactured after November 12th 2008.

In the mean time, again, you can sell as usual all Pebeo brands Setacolor Transparent, Opaque, Soleil, Setasilk and the water based Guttas in tubes as well as the Setaskrib which are all bearing the ACMI AP seal label, for no health labeling required. This means that they are non-toxic in any ways neither for adults nor children.

For your customers, regarding products they already have that were manufactured prior to November 12th 2008, you can consult the ACMI website : <http://www.acminet.org> and follow these steps:

1. Go in the certified products section, select category : ALL
2. Member : Pebeo of America
3. Select a seal : ALL
4. And submit.
5. All the Pebeo certified products will list and the specific certification and ACMI seal they

bear.
